The text of original articles includes introduction, materials and methods, results, discussion and conclusions.

Introduction

Purpose of the study

The essence and purpose of the study should be clearly defined. This section should provide the background for the study. It is necessary to justify and indicate the specific goals or hypothesis of the study.

Materials and methods

This section should include the design of the study, a description of the participants or type of material used in the work, a description of all the activities carried out, and the type of

statistical analysis. In this section, the author must declare that this study complies with the basic ethical principles.

Results

This section should describe the data obtained and the results of statistical analysis. The results should be presented in a logical sequence in the form of text, tables, and figures.

Discussion

This section should include an interpretation of the study results. These findings should be discussed in the context of other studies described in the literature.

Conclusions

Conclusions should be linked to the research objectives and formalized in a single paragraph. Conclusions should not contain unqualified statements or conclusions that are not supported by the data you receive.

Conflict of interests

The authors must declare the presence/absence of a conflict of interest.

Authors ' contribution

In this section, it is necessary to indicate the contribution (intellectual investment) of each author in the work on the article. When designing this section, the role of a specific participant in the process is indicated in accordance with the taxonomy of roles of CRediT (Contributor Roles Taxonomy) participants, followed by the first letters of the first and last names of the author/s who made the corresponding contribution.

Example filling out the section: Conceptualization – G. O.; methodology – A. S.; verification – G. O.; formal analysis – G. O., Zh. S. and B. A.; writing (original draft preparation) – G. O.; writing (review and editing) - Zh. S. All authors read, agreed with the final version of the manuscript, and signed the copyright transfer form.

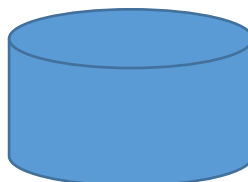


Figure 1. Title of the figure
